

**Schedule DT-RV - SUBMETERED SERVICE - RECREATIONAL VEHICLE PARKS AND RESIDENTIAL MARINAS Effective 1/1/2015**

This schedule provides domestic electric service to qualifying residents of recreational vehicle (RV) parks and residential marinas through one meter on a single premises and submetered to all RV park and residential marina tenants.
