This schedule is the utility's standard tariff for commercial customers with a demand less than 20 kW.	This Schedule is not applicable to any customer whose Maximum Monthly Demand equals, exceeds, or is expected to equal or exceed 20kW for 12 consecutive months.	Customer must have a smart meter installed, tested, and verified according to Utility procedures. This Schedule is not applicable any customer whose Maximum Monthly Demand equals, exceeds, or is expected to equal or exceed 20 kW for 12 consecutive months. Customers taking service under this Schedule will need to switch their Utility Distribution Company (UDC) service to Schedule TOU-A.
