CARE EFFECTIVE DISCOUNT WORKPAPERS

SUPPLEMENTAL FILING RULEMAKING 12-06-013 PHASE 1

Non-Residential: The Expanded CARE data is comprised of consumption data from November 2012 – October 2013 on 46 M/L C&I and 161 Small Commercial Expanded CARE accounts active in our territory during that timeframe. Each bill was calculated with EECC ELI prices, CARE Surcharge and DWR Bond Charge exemption, and 20% discount on all, then the same bill was re-calculated as a non-CARE customer — at applicable EECC, no CARE discount or CARE Surcharge exemption, and paying the DWR Bond Charge. Total annual bills are then summed by rate and customer class to obtain the CARE Discount percentages for each class reflected in the testimony. Workpapers are available upon request.

Residential: "Effective CARE Discount" is derived by taking rate revenues from effective CARE rates (including % line item discount, CARE Surcharge exemption, DWR-BC exemption and CSI exemption) divided by the rate revenues from the respective Non-CARE rates.

The columns for each year include "CARE Determinants" which are 2015 sales, "CARE Rates" which reflect rates including DWR-BC exemption and CSI exemption, "Non-CARE Rates" which are the respective Non-CARE rates for each schedule and the "Eff. CARE Rate" which includes the CARE Surcharge exemption and line item discount in addition to the tariff rate differential.

Shown below is the Effective CARE Discount calculation for the no revenue change scenario and current baseline for 2015-2018. Workpapers for the additional scenarios are available upon request.
