**AMENDMENT TO APPLICATION OF SAN DIEGO GAS & ELECTRIC COMPANY  
(U 902 E) FOR A PERMIT TO CONSTRUCT THE CLEVELAND NATIONAL FOREST  
POWER LINE REPLACEMENT PROJECTS**

**I. INTRODUCTION**

Pursuant to Rule 1.12 of the California Public Utilities Commission’s (“Commission” or “CPUC”) Rules of Practice and Procedure, applicant San Diego Gas & Electric Company (“SDG&E”) hereby submits this amendment to the above-captioned application for a Permit to Construct (PTC) the Cleveland National Forest Power Line Replacement Projects (collectively, Proposed Projects). Except as stated below, the original Application is unchanged and incorporated herein by reference.

**II. BACKGROUND**

On October 17, 2012, SDG&E filed its Application No 12-10-009 (Application) seeking authority to construct the Proposed Projects. More specifically, the Proposed Projects comprise wood-to-steel conversion and other fire hardening activities along five existing 69 kilovolt (kV) power lines within and around the Cleveland National Forest (CNF). The Proposed Projects outlined in this Application are also being evaluated concurrently by the United States (U.S.) Forest Service (USFS) in connection with SDG&E's request to renew and consolidate various

prior federal right-of-way authorizations into one Master Special Use Permit (MSUP). The primary purpose of including these reconstruction activities in the MSUP is to increase fire safety and to ensure that the electric facilities located within CNF meet current electric facility design standards.

USFS approval of the MSUP will establish the land rights and conditions for SDG&E's continued operation and maintenance of facilities within CNF. CPUC approval is not required to implement the Proposed Action currently pending before USFS in the context of the MSUP, except to the extent that the Proposed Action includes reconstruction of the 69kV power lines and such reconstruction is not exempt under G.O. 131-D.

As stated in the Application, SDG&E is not seeking individual PTCs for each of the power line projects proposed in the Application and instead has conservatively combined the five Proposed Projects into the one Application for a PTC, even though each line is separate and has independent utility. In the event CPUC review and approval of these projects continues to be unduly delayed, SDG&E reserves the right to re-evaluate these projects for exemption and/or independent review and approval.

The major components of the reconstruction activities being proposed by SDG&E have not changed; the Proposed Projects include the following elements:

- Replacement of approximately 1,384 existing wood utility poles with steel poles along five existing 69 kV power lines within and around the CNF;
- Maintenance of approximately 31 miles of existing access roads and ancillary facilities required to operate and maintain the five 69 kV power lines;
- Undergrounding of approximately 792 feet of an existing 69 kV power line and removal of the corresponding existing wood utility poles.

After the Application was filed, the USFS requested that SDG&E reconsider and expand upon certain alternatives in connection with SDG&E's request for a MSUP. To address the

alternatives requested by USFS, the CPUC directed SDG&E to revise and re-file the Preliminary Plan of Development (POD), which SDG&E prepared and submitted to USFS in support of the request for a MSUP and which was also submitted to CPUC in lieu of a Proponent's Environmental Assessment (PEA) as Volume II of the Application.<sup>1</sup> The revisions to the POD include the following amended elements:

- Potential Relocation of a portion of TL626. At the request of the USFS, SDG&E has created an approximately 3,000-footwide preliminary study corridor within which a potential alternative route may be identified; this study corridor is shown in POD Figure 7: TL626 Potential Alternative Study Corridor.
- Potential Relocation of C157. At the request of the USFS, SDG&E completed a preliminary evaluation of a number of other potentially constructible alternatives, which are depicted in POD Figure 8: C157 Potential Relocation Alternatives.

As described in the amended POD, SDG&E is not the proponent nor able to support any of these potential relocation alternatives, primarily because of the increased environmental impacts, construction challenges, customer service implications, costs, and other factors associated with these alternatives. Nonetheless, this Amendment to Application is made in compliance with the CPUC's directive to amend Volume II of the Application, and SDG&E will continue to refine its analysis into this relocation study and explore the feasibility of any other viable alternatives.

<sup>1</sup> SDG&E objects to this mandate. By filing this amendment, SDG&E does not waive, and hereby expressly reserves, its right to assert any and all arguments against alternatives to the Proposed Project in this action, or in any other proceedings, on any and all grounds including, but not limited to, due process, constitutionality, competency, relevancy, materiality, and privilege. Further, SDG&E complied with the CPUC directive to amend this application only under duress and herein without in any way implying that it considers these alternatives to be feasible.

### **III. CONTENTS OF THIS AMENDED APPLICATION**

This Application is comprised of two volumes – the Application, and a second volume containing SDG&E’s POD as a "PEA-Equivalent"<sup>2</sup> SDG&E is concurrently filing with this amendment a revised POD, consisting of volume II of II, which includes the following sections:

- Route Description
- Project Components
- Alternatives
- Right-of-Way
- Construction Activities
- Operation and Maintenance Activities
- Required Permits and Authorizations
- Preliminary Environmental Resource Evaluation

To avoid cross-references to superseded documents, SDG&E submits the amended application volume II in a restated form. It should be unnecessary to refer to the original application volume II, but we do not expect the Commission to foreclose reference to the original POD in the course of the proceeding, should any party find that useful.


**V. CONCLUSION**

## NOTICE OF AMENDMENT TO APPLICATION FOR A PERMIT TO CONSTRUCT

### Cleveland National Forest (CNF) Power Line Replacement Projects

**Date: June 26, 2013**

**CPUC Application No.: 12-10-009**

#### PROPOSED PROJECT

As previously noticed, on October 17, 2012, San Diego Gas & Electric Company (SDG&E) applied to the California Public Utilities Commission (CPUC) for a Permit to Construct (PTC) the Cleveland National Forest Power Line Replacement Projects. More specifically, the Proposed Projects comprise wood-to-steel conversion and other fire hardening activities along five existing 69 kilovolt (kV) power lines within and around the Cleveland National Forest (CNF) (collectively, Proposed Projects). The major components of the reconstruction activities being proposed by SDG&E have not changed; the Proposed Projects include the following elements:

- Replacement of approximately 1,384 existing wood utility poles with steel poles along five existing 69 kV power lines within and around the CNF;
- Maintenance of approximately 31 miles of existing access roads and ancillary facilities required to operate and maintain the five 69 kV power lines;
- Undergrounding of approximately 792 feet of an existing 69 kV power line and removal of the corresponding existing wood utility poles.

These Proposed Projects are needed to increase the fire safety and service reliability of the existing power lines within and around the CNF.

After filing the original application, the CPUC directed SDG&E to revise and re-file the Preliminary Plan of Development (POD), which is Volume II of this application, to add an alternative study corridor requested by the United States (U.S.) Forest Service (USFS). The CPUC further directed SDG&E to provide expanded notice of the Amended Application to include all owners of land within 300 feet of the proposed study corridor. As prescribed by the CPUC, Volume II of the application has been amended to include additional details on potential alternatives that may be considered during the CPUC's environmental review process. The revisions to the POD, which is available at <http://www.sdge.com/regulatory-filing/3792/application-sdge-permit-construct-cleveland-national-forest-power-line>, include the following amended elements:

- Potential Relocation of a portion of TL626. At the request of the USFS, SDG&E has created a preliminary study corridor within which a potential alternative route may be identified; this study corridor is shown in POD Figure 7: TL626 Potential Alternative Study Corridor. The study corridor is approximately 7.5 miles long, and is generally located 3.0 miles north of the intersection of Boulder Creek Road and Dubois Road, 3.3 miles west of the intersection of State Route- (SR-) 79 and Sunrise Highway, 2.8 miles east of the intersection of Eagle Peak Road and Cedar Creek Road, and 4.6 miles south of the intersection of SR-78 and SR-79. This study corridor includes private lands as well as tribal and federal government lands.
- Potential Relocation of C157. At the request of the USFS, SDG&E completed a preliminary evaluation of a number of other potentially constructible alternatives, which are depicted in POD Figure 8: C157 Potential Relocation Alternatives. These alternatives include undergrounding along portions of an existing roadway and relocating the existing overhead alignment along various new corridors.

As described in the POD, SDG&E is not the proponent nor able to support any of these potential relocation alternatives, primarily because of the increased environmental impacts, construction challenges, customer service implications, costs, and other factors associated with these alternatives. Nonetheless, this Amendment to Application is made in compliance with the CPUC's directive, and SDG&E will continue to refine its analysis into this relocation study and explore the feasibility of any other viable alternatives.

**Environmental Assessment:** SDG&E has prepared a PEA-equivalent document that includes the assessment of potential environmental impacts created by the construction and operation of the Proposed Project. The Preliminary POD serves as the equivalent to a Proponent’s Environmental Assessment. The Preliminary POD concludes there are no unmitigable long-term environmental impacts as a result of the Proposed Project. Potentially significant short-term impacts with regards to air quality due to overlapping replacement activities of the five power lines are anticipated.

**Electric Magnetic Field (EMF) Management:** SDG&E will employ measures to reduce public exposure to EMF in accordance with CPUC Decisions 93-11-013 and 06-01-042 and SDG&E’s “EMF Design Guidelines for Transmission, Distribution, and Substation Facilities.” SDG&E has filed copies of its Magnetic Field Management Plan for this Proposed Project as part of its Application.

**Public Review Process:** SDG&E has applied to the CPUC for a PTC and has asked for approval without hearings. Pursuant to the CPUC’s Rules of Practice and Procedure, within 30 calendar days of the date of notice, you may protest and request that the CPUC hold hearings on this Amended Application. Pursuant to Rule 1.12 of the CPUC Rules of Practice and Procedure, parties who have filed a reply, response, or protest to the previously-filed Application need not file an additional reply, response or protest. If the CPUC, as a result of its investigation, determines that public hearings should be held, notice shall be sent to each person or entity who is entitled to notice or who has requested a hearing.
