In response to DRA data request DRA-SDG&E-124-MRK sent in connection with Sempra's 2012 rate case, SDG&E provided DRA (now ORA) with a working spreadsheet DRA CIAC Receipts Allocations.XLS, containing CIAC payments posted to receipt accounts and activity posted to FERC accounts for the years 2000 to 2010. This spreadsheet was sent as an amended version to the spreadsheet sent in response to DRA's informal data request DRA-INFORMAL_SDG&E-MRK, the amendment being that SDG&E excluded all work orders which remained in process as of August 12, 2011.

Please now provide a similar spreadsheet for the years from 2000 to 2016, without excluding any work orders with regards to when they were initiated or terminated.
