1. Please provide an electronic Excel document for Exhibit No. SDG&E-07-CWP with working formulas.

### **SDG&E Response 1:**

That exhibit does not exist as an Excel document with working formulas. Most GRC workpapers and tables that appear in testimony are not created from, nor do they originate as, Excel spreadsheets. Most GRC workpapers and testimony tables are produced from a database system which consists of many data tables that are dynamically linked to permit grouping of cost centers and budgets, editing of historical values, selection of a forecast methodology, adjustments to forecasts and the production of workpapers. The use of a database for this purpose does not involve spreadsheets; the workpapers are formatted 'reports' from that collection of tables and linking relationships that form the database. These are derived and produced directly as PDF documents, in the case of the main workpapers, or as Word tables, in the case of the tables that appear in testimony. While these documents may appear in tabular format, they are not spreadsheets and do not contain formulae.

Notwithstanding the foregoing, SDG&E and SoCalGas will be providing a report showing the five years of adjusted-recorded historical spend and the three years of forecasts. This information is obtained as a specifically created database extract for O&M and many capital budgets, and can be provided in tabular format as a spreadsheet, although it is a report and thus consists of values and contains no formulae. In addition to the GRID-produced workpapers, joint witnesses Beth Musich and Mike Bermel have provided "supplemental" workpapers with additional descriptive information, also in PDF, which may contain tabular information that does originate as spreadsheets. Those "supplemental" workpapers, and witness workpapers not produced through the GRC database system that may exist in Excel spreadsheet format, have been provided to ORA in one or more batches via email to Clayton Tang, first initiated on Tuesday, October 24, 2017. Please refer to those files in response to this question.
