Access to non-public versions of the forgoing reports will be made available pursuant to an executed Non-Disclosure Agreement (NDA). The public versions of the reports redact certain customer information to comply with the Decision Adopting Rules to Provide Access to Energy Usage and Usage-Related Data While Protecting Privacy of Personal Data, D.14-05-016 (Decision). In the Decision, the Commission stated: "we . . . retain a requirement of a minimum aggregation standard of fifteen customers per zip for residential, agricultural and commercial customers." The Commission also states: "we . . . follow a 15/15 Rule for public posting of data concerning commercial, industrial and agricultural data." (D.14-05-016, page 118; and Finding of Fact 17.) SDG&E has redacted from the reports information where there are fewer than 15 customers involved or where a single customer in the group accounts for more than 15% of the aggregated total and absent redaction, private individual customer information would be disclosed, specifically with regard to six programs: (1) Demand Bidding – Day of; (2) Demand Bidding – Day Ahead; (3) Capacity Bidding Program – Day Ahead; (4) Capacity Bidding Program TA/TI; (5) Permanent Load Shifting; and (6) the Base Interruptible Program.
