REQUIRING UTILITIES TO FILE SUPPLEMENTAL INFORMATION AND
NOTICE OF AVAILABILITY OF SUPPORTING EXHIBITS**

San Diego Gas & Electric Company (SDG&E) hereby provides its additional response to the Administrative Law Judge Ruling Requiring Utilities to File Supplemental Information issued March 30, 2015, as modified by ALJ McKinney's electronic Ruling issued April 1, 2015. SDG&E also hereby provides notice of the availability of attachments referenced in and supporting this Response.

I. NOTICE OF AVAILABILITY OF SUPPORTING EXHIBITS

II. ADDITIONAL RESPONSE TO RULING REQUIRING UTILITIES TO FILE SUPPLEMENTAL INFORMATION

On April 1, SDG&E provided responses to:

- Section I: 2015 Projected Rates;
- Section II: Additional Rate Impact Scenarios
 - Scenarios 1-7 resulted in 44 defined rate scenarios; Non-CARE and CARE rates for 2015, 2016, 2017, and 2018.
 - Illustrative bill impacts based on monthly kWh usage for the tiered rate Scenarios 1-3 reflecting:
 - Comparisons of Projected Year-End 2015 to 2015, 2015 to 2016, 2016 to 2017, and 2017 to 2018;
 - Non-CARE and CARE;
 - SDG&E's four climate zones: Inland, Coastal, Mountain, and Desert;
 - Basic and All-Electric service; and
 - Illustrative bills presented reflect annual as well as summer and winter bills.
- Section III: Most Current Available Statistics on Residential Customers – response to questions 1-16.

SDG&E originally anticipated supplementing the April 1 Response with additional information on April 8th. On April 7th, SDG&E requested an extension through April 13th to provide the supplemental information.

SDG&E provides the following information to supplement its April 1 response to the ALJ March 18th Ruling:

- **Attachment A**: Population level bill Impacts based on SDG&E's 1.2 million residential population for Rate Scenarios 1-7 that reflect:
 - The following Bill Comparisons:
 - In response to II.A., for each Rate Scenario, Year-to-year Comparisons that reflect: (1) Projected Year-End 2015 to 2015, (2) 2015 to 2016, (3) 2016 to 2017, and (4) 2017 to 2018;
 - In response to II.B., for each Rate Scenario, Cumulative Comparison that reflect: (1) Projected Year-End 2015 to 2018, and (2) August 1, 2014 effective rates to 2018; and
 - Comparison of (1) August 1, 2014 effective rates to February 1 effective rates, and (2) February 1 effective rates to Projected Year-End 2015.

- Population level bill impacts that reflect:
 - Non-CARE and CARE;
 - SDG&E’s four climate zones: Inland, Coastal, Mountain, and Desert. Note: In the Table of Contents that precede each Rate Scenario, the order in which the Mountain and Desert climate zones as presented in the Table of Contents is flipped for Basic and All-Electric services, that is in the following documents Desert precedes Mountain for Basic and All-Electric service. The individual table pages identifying Mountain and Desert are correctly labeled;
 - Basic and All-Electric service; and
 - Illustrative bills presented reflect annual as well as summer and winter bills. Note: Customers are assigned usage bins based on annual usage and remain in that same usage bin in all presentations, therefore, the presentation of average seasonal usage may not tie to the usage bin.
- **Attachment B**: In response to II.D., Energy Burden for Rate Scenarios 1-7 based on annual bills that reflect:
 - Non-CARE and CARE;
 - SDG&E’s four climate zones: Inland, Coastal, Mountain, and Desert; and
 - Basic and All-Electric service.
- **Attachment C**: In response to II.C., The NEM bill impacts that reflect Rate Scenarios 1-7 include all NEM customers on the standard CARE and non-CARE tiered rates and reflect annual bills, not differentiated by climate zone or service type.

With regard to II.E., Hot/Mild Climate Zone Bill Impacts by Year and Cumulative, SDG&E’s climate zone we identified in the March 18th Ruling as the following:

- Mild: Coastal
- Hot: Inland
- Hot: Mountain
- Hot: Desert

SDG&E’s four climate zones are presented individually in the responses to II.A. and II.B.

III. CONCLUSION

SDG&E appreciates the opportunity to submit the forgoing responses to ALJ McKinney's request for supplemental information.
