Pursuant to Rule 1.9 of the Commission Rules of Practice and Procedure, San Diego Gas & Electric Company (SDG&E) hereby provides Notice of Availability of Bill Impacts for Proposed Decision and Alternate Proposed Decision in response to the Administrative Law Judge (“ALJ”) Ruling issued June 8, 2015 Requiring Pacific Gas and Electric Company (PG&E), Southern California Edison Company (SCE), and San Diego Gas & Electric Company (SDG&E) (“June 8 ALJ Ruling”) to serve and file supplemental information. Consistent with the June 8 ALJ Ruling, responses to Sections I and II were provided on June 12, 2015 and the responses to Section III are provided in Attachments A and B. SDG&E hereby provides notice that the following have been posted on SDG&E’s website:

- A. Main Bill Impact Table by Year: Using Bill Impact Presentation Templates to show year over year rate changes, including tables for CARE and Non-CARE customers, and including separate tables for the each Climate Zone depicting impacts for both the PD and APD end-state rates.
- B. Main Bill Impact Table Cumulative: Using Bill Impact Presentation Templates to show the cumulative rate change between 2014 and 2018, and including tables for CARE and Non-CARE customers and separate tables for each Climate Zone, depicting impacts of both the PD and APD end-state rates.
