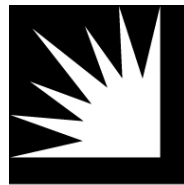

4 Q. Please state your name and business address for the record.

5 A. My name is Robert D. Bledsoe, and my business address is 5000 S. Pacific Coast Highway, San
6 Clemente, California 92674.

7 Q. Briefly describe your present responsibilities at the Southern California Edison Company.

8 A. I am presently a project manager for Edison's Financial and Operational Services Department,
9 assigned to the San Onofre Nuclear Generating Station (SONGS). I perform special projects,
10 including developing submittals to the CPUC regarding SCE's responsibilities for
11 decommissioning SONGS and the Palo Verde Nuclear Generating Station (Palo Verde).

12 Q. Briefly describe your educational and professional background.

13 A. I earned a Bachelor's Degree in Business Management from the Brigham Young University in
14 1981, an MBA from UC Irvine in 1990, and a Juris Doctor Degree from Western State
15 University College of Law in 1999. I completed Project Management certificate program from
16 UC Irvine Extension in 2014. I joined Edison in 1982, and was assigned to the Site Emergency
17 Preparedness Division at SONGS. In that assignment, I coordinated the implementation of the
18 fire protection programs at SONGS. Since then, I have worked in a variety of areas, with
19 increasing levels of responsibility, in support of SONGS operations and decommissioning. In
20 1987, I transferred to the Nuclear Information Services Division as a Computer Applications
21 Engineer. There, I developed and implemented computer software applications to support the
22 SONGS fire protection and work process control programs. In 1992, I transferred to the Nuclear
23 Rate Regulation and Participant Services Division, where I worked as a staff specialist on
24 numerous rate related matters pertaining to SONGS and Palo Verde. In 1997, I became Edison's
25 representative on the Palo Verde Engineering and Operations Committee. In 1998 I became
26 involved in planning for the SONGS 1 decommissioning project, and served as a project
27 manager throughout that effort. There, I was responsible for developing Edison's submittals for

1 each NDCTP. In 2008, I transitioned to the SONGS Finance Department, where I continued to
2 be responsible for Edison's NDCTP submittals.
