

**Schedule DT - SUBMETERED MULTI-FAMILY SERVICE - MOBILEHOME PARK (closed to new customers) Effective 3/1/2019**

Schedule DT provides service for multi-family accommodations in a mobilehome park receiving service through a single meter and submetered to all individual tenants. This schedule has been closed to new customers since January 1, 1997.
