

Schedule DT - SUBMETERED MULTI-FAMILY SERVICE - MOBILEHOME PARK (closed to new customers) Effective 6/1/2022

The following are the CARE rates associated with service under Schedule DT. Schedule DT provides service for multi-family accommodations in a mobilehome park receiving service through a single meter and submetered to all individual tenants. This schedule has been closed to new customers since January 1, 1997.

Notes:

- The total rates presented reflect the UDC rates associated with service under Schedule DT - CARE and the generation rates associated with Schedule EECC. In addition, they include the line-item discount and exemptions from the CARE surcharge, DWR Bond Charge, Wildfire Nonbypassable Charge, VGI and CSI surcharge as identified in Schedule E-CARE. The UDC rate-by-rate components presented are associated with service under Schedule DT - CARE as presented in the utility's tariff book.
- Unbundled customers are those who take generation from other providers, such as Direct Access (DA) or Community Choice Aggregation (CCA). Unbundled customers do not pay SDG&E's commodity rates. The Total Energy Charge for an unbundled customer includes UDC, WF-NBC, DWR-BC and Power Charge Indifference Adjustment (PCIA) rates. PCIA rates by vintage are included below.
