[SDG&E's Rebuttal Testimony, Chapter 1](#), pp. BAS-3-4, lines 18-7 states, "The testimony of the Utility Reform Network ("TURN") argues that the economic situation caused by the COVID-19 pandemic calls for an increased Commission focus on affordability. Indeed, the ongoing pandemic has devastated the San Diego region, contributing to an unemployment rate of over 30% in San Diego County as of early May 2020, the most recent date for which data was available. However, the pandemic's impact are all the more reason to accelerate utility investments in TE. In this time of record unemployment SDG&E is helping the San Diego region recover by opening new hiring, training and apprenticeship programs, including for trained tradespeople to install EV infrastructure –including potentially the PYD Extension Program."

- a. Please provide the approximate population in San Diego County facing unemployment based on the 30% figure. Please provide all supporting sources and calculations.
- b. Please provide any information and all sources regarding the previous incomes of now unemployed individuals – e.g. did they have generally lower, middle, or high incomes? Please provide all supporting sources and references.
- c. Please provide the percentage of unemployed by employment sector (e.g. service, engineering, etc.) where the 30% were previously employed. Please provide all supporting sources, workpapers and calculations.
- d. Please provide the number of new jobs the PYD Extension program will create. Please provide all supporting sources, workpapers, and calculations.
- e. Please provide the number of San Diego County residents who will, or are likely to, gain jobs if the PYD Extension program is approved as proposed. Please provide all supporting sources, workpapers, and calculations.
- f. Please provide the number of San Diego County residents who will, or are likely to, gain jobs if the PYD Extension program is approved as proposed by TURN (1,000 ports rather than 2,000). Please provide all supporting sources, workpapers, and calculations.
- g. Please provide the number of new employees hired on a full-time basis to SDG&E due to implementation of the PYD Pilot program, and provide a short description of the jobs they were hired for. Please provide all supporting sources and workpapers.

**SDG&E Response**

The source referenced in the testimony was taken from a news report that stated: “San Diego County's estimated unemployment rose to a record-high 30.1% this week, according to a report released Thursday by the San Diego Association of Governments, The report says 22,800 jobs were lost between May 2 and May 9 and more than 510,000 are unemployed in the San Diego region as of May 9. Of those, nearly 460,000 people lost their jobs after March 7.”
