The California Public Utilities Commission (CPUC) will hold Evidentiary Hearings at the time and place noted above to review San Diego Gas & Electric Company's (SDG&E<sup>®</sup>) request to increase certain electric rates and update cost allocation and rate design.

At these Evidentiary Hearings, SDG&E, consumer advocacy groups, and other parties to this proceeding testify before a CPUC Administrative Law Judge (Judge) regarding SDG&E's request. The public can attend and listen to the hearings but are not allowed to testify.

**Please note:** Due to the Governor's directive and CPUC's ongoing efforts to protect customers and community members during COVID-19, the CPUC may determine that there will be no in-person physical location for the Evidentiary Hearings and may instead hold the hearings through other means such as via internet or via phone participation. Therefore, please monitor the CPUC's daily calendar (located at [www.cpuc.ca.gov](http://www.cpuc.ca.gov)) for any changes relating to the Evidentiary Hearings and the manner in which they will be held.

**What is SDG&E's application?**

On March 4, 2019, SDG&E filed its General Rate Case (GRC) Phase 2 Application (Application) with the CPUC, seeking approval to increase certain electric rates for its customers. This Application proposes no changes to total revenue because revenue changes were approved by the CPUC in SDG&E's GRC Phase 1 Decision (D.19-09-051), issued on October 1, 2019. In addition, this Application requests no changes to gas rates.

**How does the rest of this process work?**

This application has been assigned to a Judge who will consider proposals and evidence presented during the formal hearing process. The Judge will issue a proposed decision that may adopt SDG&E's application, modify it, or deny it. Any CPUC Commissioner may sponsor an alternate decision with a different outcome. The proposed decision, and any alternate decisions, will be discussed and voted upon by the CPUC Commissioners at a public CPUC Voting Meeting.

Parties to the proceeding are currently reviewing SDG&E's application, including the Public Advocates Office, which is an independent consumer advocate within the CPUC that represents customers to obtain the lowest possible rate for service consistent with reliable and safe service
