 - c. Do the costs included in Table CRO-16 include all costs or just direct costs? If the latter, provide a table with the direct, indirect and total cost for each of the 19 projects included as Electric Distribution sponsored IT projects in Exhibit 24 workpapers.

SDG&E Response 01:

- a. a. A cost center is a distinct organizational unit within SDG&E to which costs are charged, it can be synonymous with a 'section' or similar terminology.
- b. Electric Distribution cost centers are not charged for the capital development or acquisition of IT projects.
- c. Capital project costs are shown as direct costs only.
