Request 1:

San Diego Gas & Electric Company's (SDG&E)'s Application for the Power Your Drive (PYD) Extension¹ mentioned that there are hundreds of potential site hosts on the PYD interest list.²

- a. Please disclose the total number of potential sites that are on the PYD interest list as of this data request's submission date.³
 - i. How many of these sites would qualify under a statewide DAC (disadvantaged community) definition? Here, a statewide definition is the top quartile of disadvantaged census tracts using the CalEnviroScreen 3.0 Tool.⁴
 - ii. How many of these sites would qualify under a service-territory DAC definition? Here, a service-territory definition is defined as the top 25% of disadvantaged census tracts within SDG&E's service territory as defined by the CalEnviroScreen 3.0 Tool.
 - iii. How many of these sites are located in an AB 1550 low-income community?⁵

SDG&E Response:

- a. Please see *Response of ... [SDG&E] to Administrative Law Judge's Ruling* (July 20, 2020) for background on the interest list. The Refined Interest List (as defined in SDG&E's July 20 response) currently has 489 potential sites, an increase of 19 sites over the number of sites identified in SDG&E's July 20 response (at 470). The Refined Interest List will continue to update based on new information from site requestors and ongoing curation.
 - i. The Refined Interest List has 45 sites located in Statewide DACs.

- ii. The Refined Interest List has an additional 115 sites that are located only in service territory DACs bringing the total number of interest list sites that are located in service territory DACs to 160.

- iii. The Refined Interest List has 177 sites located in census tracts that have been designated as Low Income Communities. 48% of California’s census tracts are considered Low Income Communities compared to 40% of census tracts located in SDG&E’s service territory.
