**NOTIFICATION OF  
SAN DIEGO GAS & ELECTRIC COMPANY'S  
REQUEST TO INCREASE ELECTRIC RATES  
NO. A.21-12-006**

**WHY AM I RECEIVING THIS NOTICE?**

On December 13, 2021, San Diego Gas & Electric Company (SDG&E®) filed an application with the California Public Utilities Commission (CPUC) for approval of a Real Time Pricing (RTP) Pilot. If approved, the application will result in an **increase in electric rates**, starting January 1, 2023. The total costs of the requested improvements and associated support are approximately \$2.6 million over 9 years. As authorized in CPUC Decision (D.) 21-07-010, SDG&E requests the approved amount be recorded in a proposed new balancing account.

**WHY IS SDG&E REQUESTING THIS RATE INCREASE?**

- SDG&E was required by CPUC D.21-07-010 to propose an RTP dynamic rate pilot. SDG&E is submitting this application to comply.
- The proposed RTP pilot will give pilot participants day-ahead hourly price signals, which will allow them to adjust their electric usage accordingly. The potential benefits of an RTP rate that are being tested by the pilot include: reduced grid costs, reduction in greenhouse gases, increased use of renewable energy and improvements in grid reliability.
- The application covers potential costs associated with planning and implementing the pilot, such as obtaining stakeholder input, building out system enhancements, customer marketing and outreach, customer notifications and establishing a team that will oversee and evaluate the pilot.



## HOW COULD THIS AFFECT MY MONTHLY ELECTRIC RATES?

If the CPUC approves SDG&E's request for an RTP Pilot in this application, the average bill for a typical bundled residential customer<sup>1</sup> living in the inland and coastal climate zone and using 400 kWh per month would increase \$0.02 (or 0.0%) in 2023. Individual customer bills may vary. If approved, new rates would become effective with the next available rate change.

## HOW COULD THIS AFFECT MY MONTHLY GAS RATES?

SDG&E's request will not have any impact on gas rates.

## HOW DOES THE REST OF THIS PROCESS WORK?

This application will be assigned to a CPUC Administrative Law Judge, who will consider proposals and evidence presented during the formal hearing process. The Administrative Law Judge will issue a proposed decision that may adopt SDG&E's application, modify it or deny it. Any CPUC Commissioner may sponsor an alternate decision with a different outcome. The proposed decision, and any alternate decisions, will be discussed and voted upon by the CPUC Commissioners at a public CPUC Voting Meeting.

<sup>1</sup> A bundled customer is one who takes both Utility Distribution Company (UDC) and commodity service from SDG&E, such as on rate Schedule TOU-DR1.

<sup>2</sup> Represents customers who take bundled service.
