SDG&E expects to implement its proposals in 2021, once CIS is on-line. SDG&E does not have a more precise date than that.

SDG&E Response:

SDG&E is able to complete pricing changes during this time. For example, SDG&E will be able to implement the pricing changes that will occur when moving from Winter to Summer rates in June 2020. SDG&E will not be able to implement any rate design changes (other than pricing), implementation of a new customer class, or any new rate schedules.

b. If SDG&E is able to change any rate elements in 2020 when its information systems are "frozen," is SDG&E proposing to change any rate elements in 2020 as a result of SDG&E's proposals in the instant proceeding? If your response is anything except an unqualified "no," please list all rate elements that SDG&E plans to change in 2020 as a result of the instant proceeding.

SDG&E Response:

SDG&E Response:

SDG&E expects to implement its proposal sometime in 2021 after the implementation of the CIS replacement project. Assuming there is a Commission decision on SDG&E's 2019 GRC Phase 2 application by the 3rd Quarter of 2020, SDG&E will implement proposals as directed by the Commission decision. As there are operational considerations and planning required to implement decisions with rate design changes or introduction of new rates, if SDG&E receives a Commission decision in 2020, expected implementation of its proposals would be in 2021.

SDG&E Response:

SDG&E's proposed implementation date is during 2021. Year 1 is representative of 2021 and Year 2 is representative of 2022.
